

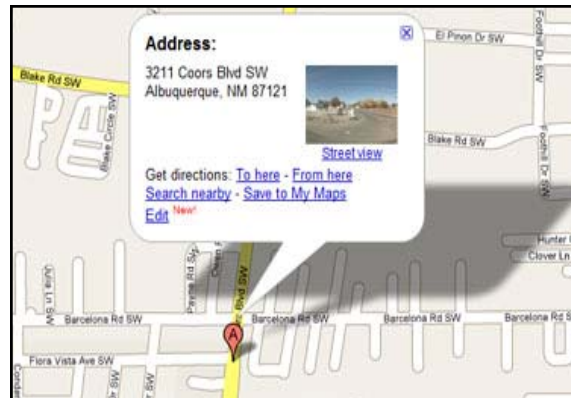
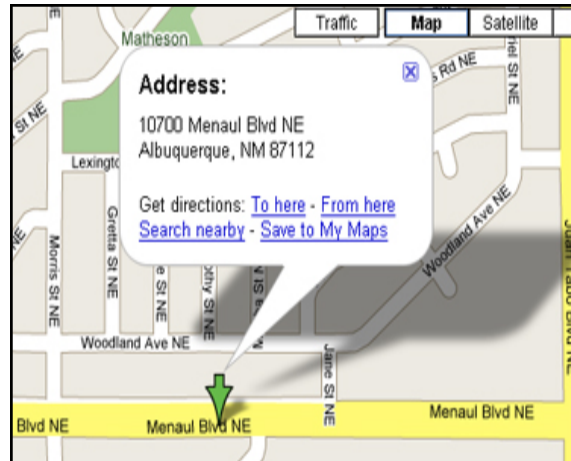
Self-Insured Employer Plan

- CDL physical if required
- Yearly flu shot
- Tetanus shot
- Hepatitis A vaccine if required
- Hepatitis B vaccine series if required
- TB testing if required
- Screening chest-xray if required
- Pulmonary Function Tests if required

* Includes pre-employment assessment and does not include labs, medicine, or diagnostic tests (ultrasound, MRI, etc) referred out of office. Also does not include medication for chronic problems.
